CAUTIONARY STATEMENT TO OWNERS OBTAINING BUILDING PERMITS (Part of Ply 4 for Applicants)

101.65(lr) of the Wisconsin Statutes requires municipalities that enforce the Uniform Dwelling Code to provide an owner who applies for a building permit with a statement advising the owner that:
